**UBC is not responsible for infringing copies made or transmitted by photocopiers and scanners made available on its premises.**

**Copyright law applies to you and the material you are about to copy or scan.**

Copying or scanning a copyrighted work is copyright infringement, unless:

you are acting under an exception to copyright infringement (several of which are described below),

or

you have permission from the copyright owner.

**Infringing copyright can have serious legal and financial consequences for you and UBC.**

## *Common Exceptions to Copyright Infringement*

**FAIR DEALING:** anyone may make a copy for purposes of research, private study, criticism, review, news reporting, education, parody or satire, provided the copying is fair.\*

**In practice, this means that if you are UBC faculty or staff, and you are making a copy for any of the purposes listed above, you may copy or scan up to 10% of a copyrighted work, or the following, whichever is greater:**

- one chapter from a book;
- a single article from a periodical;
- an entire artistic work (including a painting, print, photograph, diagram, drawing, map, chart and plan) from a copyrighted work containing other artistic works;
- an entire newspaper article or page;
- an entire single poem or musical score from a copyrighted work containing other poems or musical scores; or
- an entire entry from an encyclopedia, dictionary, annotated bibliography or similar reference work

### OTHER EXCEPTIONS

**If you are UBC faculty or staff,** you may copy or scan the following:

- A work to display in a UBC classroom, provided the work is used for the purpose of education and training and is not already available in a commercial format;
- A work as required for a test or examination, provided the work is not already available in a commercial format; and
- An entire work (other than a film or movie) for the purpose of making the work available in an alternative format including translation, adaptation and performance in public (except the making of a large-print book) for the purpose of serving students with perceptual disabilities as long as such adaptation is not already commercially available in that format.
